The course has six Educational Functioning Levels (EFL), from Foundations to Advanced. The levels match the federal National Reporting System (NRS) levels. Combining the students of two or three levels in the same classroom is allowed if an agency has few students. The recommended class size is no more than 20 students per class. Students in this course must take a pretest and posttest in both L and R to be placed and to pass the levels of the course, Foundations through Advanced. Use the lower of the two scores to determine the student's EFL for the NRS. How are Students must be tested with a state-approved assessment. The approved tests are BEST Literacy, students BEST Plus, CASAS (L and R), and TABE CLAS-E (L and R). tested? Students must take a posttest after completing a certain number of hours of instruction. BEST Literacy and BEST Plus recommend 80-100 hours of instruction before posttesting. CASAS recommends 70-100 hours of instruction. TABE CLAS-E recommends 60 hours of instruction. The standards for this course are approved by the FLDOE annually.
